

St Helena Hospice Charity Golf Day 2026 - Terms and Conditions

1) General

- a. These booking terms and conditions apply to everyone participating in St Helena Hospices Charity Golf Day. Those who attend as spectators and upon entry you accept these terms and conditions.
- b. Places are limited on the event, and entries are processed in the order we receive them. The closing date for entries is Friday 12th June 2026 at 11.59pm.
- c. There is a minimum age for participants to register at 16 years. Anyone under the age of 18 must be accompanied by a registered adult who takes responsibility for them at all times throughout the event. Anyone under the age of 18 agrees that they have sought parent/guardian consent to take part in this event.
- d. When registering via Enthuse, you will be required to register the team of 4 and declare the names of each participant.

2) Booking process, prices and payment

- a. Registration is non-transferable and non-refundable.
- b. The registration fee for this event is £280 per fourball.
- c. We are offering 'hole sponsorship' at the event for £250 inclusive of 'one free' place.
- d. The Charity Golf Day is a St Helena Hospice event to raise money for St Helena Hospice.
- e. Any carer taking part to accompany a participant should contact the fundraising team to discuss their attendance on the day.
- f. All funds raised from registering to take part in this event, including donations and money received on the day will be allocated to general hospice funds to cover all St Helena Hospice services.

3) Awards, Prizes & Raffle

- a. Awards or prizes will be handed out to those winning competitions on the day, i.e. closest to the pin, longest drive provided by St Helena Hospice.
- b. Best team and individual player will receive an award provided by St Helena Hospice.
- c. A raffle will be available on the day and drawn on the day with winners collecting prizes on the day.

4) Safety

- a. All participants taking part in the charity golf day do so at their own risk. In no event shall St Helena Hospice be liable for any injuries, loss or damages whatsoever, including indirect, punitive, special, incidental or consequential losses connected with any aspect of this event.
- b. All participants are responsible for their own medical condition. If in doubt about your ability to attend the event or you have a medical condition that might affect your ability to participate, please consult your doctor prior to taking part in the event.
- c. On no account are drugs or alcohol to be brought into the event site or consumed during the event. St Helena Hospice reserves the right to refuse entry to anyone we suspect is under the influence of drugs or alcohol.
- d. Lexden Wood Golf club (venue host) reserve the right to ensure the safety and wellbeing of all those in attendance at the club.
- e. Disabled entrants are welcome to take part. Please contact St Helena Hospice prior to booking to establish whether the event is suitable for you.

5) Changes to the event

- a. St Helena Hospice cannot be held liable for any changes made to the event for safety reasons. Nor can we accept any liability for any changes made to the venue or date of the event.
- b. St Helena Hospice reserves the right to alter the start time of the event at any time.
- c. If St Helena Hospice cancels the event due to reasons beyond control such as snow, thunderstorms, natural disasters and terrorism, entry fee will not be refunded. An alternative date will be selected and all participants will be admitted to this event.

- d. St Helena Hospice reserves the right to cancel this event at any time due to reasons within our control. In the event of this happening, entry fees and sponsorship will be refunded in full.

- b. No personal details (including names) of anyone under 18-year-old participants will be used in any publicity materials without the written consent of their parent or legal guardian, but we may use images where children are incidentally included.
- c. St Helena Hospice utilise the services of a third party marketing support such as photographers and will only use this filming or photography as instructed by St Helena Hospice for marketing purposes ONLY.
