St Helena Hospice Dedham Wine Walk Terms and Conditions

1. General

a. These booking terms and conditions apply to everyone who takes part in St Helena Hospice 'Dedham Wine Walk' 2025 and those who attend as spectators.

b. These terms and conditions contain important information regarding participation and upon entry you agree to, and accept these terms and conditions.

c. Places are limited in the event and entries are processed in the order we receive them. The closing date for entries is Wednesday 9th July 2025 at Midnight. All participants wishing to take part after this time will need to sign up and pay on the day of the event (spaces permitted)

d. The age for registrations and participation in the event is anyone over the age of 18.

e. All participants taking part in the event do so at their own risk. In no event shall St Helena Hospice be liable for any injuries, loss or damages whatsoever, including indirect, punitive, special, incidental or consequential losses connected with any aspect of this event.

f. All participants are responsible for their own medical condition/s. Should you have a medical condition or if you are in any doubt about your ability to participate and finish the Dedham Wine Walk, we advise you to seek medical advice from a general practitioner prior to the event.

g. Photographs and videos will be taken of participants throughout the event, these will be used on promotional materials to publicise the event and the work of the charity generally. It is the participant's responsibility to let staff know at registration if you do not want to appear in any such materials.

h. No dogs are permitted within the vineyard and therefore not able to attend the event.

2. Booking process, prices and payment

a. The entry fee is non-refundable and non-transferable.

b. Participants are charged the following:

- Standard Ticket without food = £35
- Standard Ticket with food = £45
- A discount code will run for first 4 weeks of launch and is a £5 discount code. St Helena reserve the right to extend or include any discount codes throughout registration dates.

c. Ticket Prices on the day are £50.

d. The Dedham Wine Walk is a St Helena Hospice event to raise money for St Helena Hospice. We ask that any sponsorship raised is for St Helena Hospice, please do not raise money for other charities, trusts or funds.

e. Any carer taking part is able to accompany a participant free of charge. It is recommended you contact the fundraising team ahead of booking to confirm this.

f. There is no sponsorship target for this event. However, supporters are welcome to fundraise and can do so by creating their own fundraising page.

g. All funds raised from taking part in this event, including sponsorship will be allocated to general hospice funds to cover all hospice services.

h. Bespoke gift from St Helena Hospice is subject to availability and cannot be guaranteed for people registering on the day.

3. Safety

a. The Dedham Wine Walk is 5km and is open to adults only (18 years and over).

b. The 5km distance is through the vineyard and will be marshalled along the route. Any safety advice will be shared ahead of the event and at the 'briefing' ahead of the walk commencing.

c. Due to the nature of the event and alcohol, we will operate 'challenge 25' to support alcohol consumption on the premises at Dedham Vale Vineyard.

d. Disabled entrants are welcome to take part. However, consideration should be given to the distance and nature of the event.

e. Alcohol consumption is to be monitored at the event and St Helena Hospice reserves the right to refuse purchasing of alcohol to anyone deemed unfit to do so.

4. Clothing

a. Due to the theme of the Dedham Wine Walk, all participants are encouraged to dress comfortably for the walk and wear appropriate footwear (walking or running shoes). St Helena Hospice is not responsible for any damage, wear or tear to such items.

b. There will be no changing or bag drop facilities at the event.

5. Changes to the event

a. St Helena Hospice cannot be held liable for any changes made to the event for safety reasons, or as otherwise planned through circumstances beyond their control. Nor can they accept any liability for any changes made to the venue or date of the event.

b. St Helena Hospice reserves the right to alter the start time of the event at any time.

6. Cancellation

a. St Helena Hospice reserves the right to cancel this event at any time. In the event of this happening, entry fees and sponsorship will be refunded in full.

7. Data protection

a. The information you provide at registration will be shared only with St Helena Hospice; it will not be passed onto any other organisation.

b. By taking part in the Dedham Wine Walk event you consent to St Helena Hospice contacting you via telephone, letter or email for any matter relating to your participation in this event.

c. All participants are responsible for ensuring they receive and understand all communication regarding the event, including the terms and conditions.

d. We require the postal and email addresses of each participant so we can send them important information about the event. By providing this information, they are not opting into any email marketing, they will only be sent information about this event.

a. All participants taking part in Dedham Wine Walk do so at their own risk. In no event shall St Helena Hospice or Dedham Vale Vineyard be liable for any injuries, loss or damages whatsoever.

b. All participants taking part will be aged 18 or over on the event date.

c. All participants are advise to 'drink' responsibly and St Helena Hospice take no liability for any injury, loss or damages caused because of this.
